Menominee County OKs ARPA funds

Remaining \$1.4M approved for roads, other uses

MENOMINEE-The Menominee County Board last week stipulating the funds be used

agreed to the Finance Committee's recommendations for allocating the remaining American Rescue Plan Act funds to local roads and other uses.

The board approved without opposition the recommended allocation for the remaining \$1.4 million in American Rescue Plan Act funds, including up to \$750,000 for local roads over three years. The commissioners requested the resolution avoid

only for gravel roads. "It would be helpful to not be bound by a word," said Commissioner William Cech, vice chairman of the board. Commissioner Larry Schei's absence was excused, though he participated in the meeting online. A Michigan statute requires in-person attendance to vote.

The allocation also includes \$250,000 for economic development, \$100,000 for the parks fund, \$150,000 for a courthouse camera system and \$160,000 for but the county board denied the the Shakey Lakes Dam Project.

The board also approved a Finance Committee recommendation to hire for up to \$10,368 one limited-term employee this summer for the Equalization Department. When time permits, the worker also will help in the County Clerk's Office. Equalization Director Candace Curran Whitehouse had requested funds to hire two summer workers for a total cost of about \$20,000,

request at its May 10 meeting. The \$10,368 will be paid from the general fund.

Carviou announced the county received a grant for about \$143,000 for training and recruiting first responders. He intends to apply for a materials handling grant from CUPPAD.

Menominee County opposes property tax bill

Commissioners believe private companies would benefit

MENOMINEE-The Michigan legislation the Menominee County Board opposed in a resolution passed at the May 24 board meeting would strengthen existing laws requiring property tax records and other property information be provided to the public at a reasonable cost.

In discussing the resolution, which Menominee ounty Commissioners passed without opposition County Administrator Jason Carviou said the bill would benefit for-profit companies like Zillow at the expense of taxpayers. He said it would create a system where Zillow could get public records at no charge. But Zillow disputed this characterization of the bill. "Zillow will compensate counties for their actual costs in providing this information as prescribed under Michigan state law," said Will Lemke, communications manager at Zillow. The resolution said the commissioners oppose the bill "as private corporations should not benefit financially from public records at the expense of the Michigan taxpayers." The county will send a copy of the resolution to Gov. Gretchen Whitmer, State Sen. Ed McBroom, State Rep. Beau LaFave, Rep. Julie Calley and Michigan associations of counties, county treasurers, county clerks and register of deeds. 'Not only does it create a burden on our county offices to go through and pull those records and make them available to these companies, but the taxpavers have to pay for that then," Carviou said. "Then the taxpayers are on the hook for giving them publicly owned information. The resolution opposed four bills-House Bills 4729, 4730, 4731 and 4732-pertaining to public records from the county treasurer, county clerk and the Register of Deeds. House Bill 4730 is the only one that's passed the Michigan House of Representatives and is expected to be considered by the Senate, according to Brad Ward, vice president of public policy and legal affairs at Michigan Realtors, an association with 35,000 members. 'Michigan Realtors supports the bill," Ward said. "Because they do help the consumer, the home buying public as well as our members, we believe these are public records that should be available at reasonable fees."
